

NDC ENDORSEMENTS IN THE 116TH CONGRESS

- <u>H.R. 1</u>, the For the People Act, a sweeping campaign finance and election reform bill that seeks to restore the voice of the American people in their democracy by making it easier to vote, ending the dominance of big money in the political process and ensuring public officials work for the public interest.
- <u>H.R. 4</u>, the Voting Rights Advancement Act, introduced by NDC Vice Chair Terri Sewell. The legislation seeks to address the most egregious forms of recent voter suppression by developing a process to determine which states and localities with a recent history of voting rights violations must pre-clear election changes with the Department of Justice.
- H.R. 5, The Equality Act, a bill to ban discrimination against LGBTQ individuals in arenas such as housing, employment, federal funding, education, credit access, and jury service.
- <u>H.R. 6</u>, the Dream and Promise Act, which provides permanent status and a pathway to citizenship for Dreamers, Temporary Protected Status (TPS) holders, and Deferred Enforced Departure (DED) recipients.
- H.R. 9, the Climate Action Now Act, a bill that would prevent America from abandoning the Paris Climate Agreement, committed to by every other nation on the planet.

- New Dem Rep. Dean Phillips' <u>H.R. 7010</u>, the Paycheck Protection Program (PPP) Flexibility Act, to make critical improvements to the PPP to ensure increased flexibility and access to its resources.
- H.R. 7120, The George Floyd Justice in Policing Act, a bicameral, comprehensive bill to better hold police accountable, change the culture of law enforcement, and build trust between law enforcement and communities.
- H.R. 1636, the Commission on the Social Status of Black Men and Boys Act, which was introduced by a bipartisan group of Members, including New Dem Reps. Lucy McBath (GA-06) and Cedric Richmond (LA-02). The bill establishes a bipartisan commission made up of lawmakers and experts housed within the U.S. Commission on Civil Rights to study the societal forces that have a disproportionately impacted black males in America.
- <u>H.Res. 746</u>, a House resolution introduced by NDC Trade Task Force Co-Chair Ron Kind (WI-03). The resolution reaffirms the United States' commitment as a Member of the World Trade Organization (WTO) and the need to work with other members to achieve much-needed reforms of the WTO.
- <u>H.R. 8015</u>, the Delivering for America Act, to provide additional funding to the United States Postal Service and prohibits any changes to the operations or service levels that would impede prompt, reliable, and efficient service for the duration of the coronavirus crisis or through January 2021.
