Dear Subcommittee Chairman Womack, Subcommittee Ranking Member Clyburn, Chairman Cole, and Ranking Member DeLauro:

For decades, the Committee on Appropriations has acted to fund infrastructure programs and ensure the safety of the United States' transportation systems. The New Democrat Coalition shares your commitment to infrastructure that meets the needs of the American people and recognizes that innovative policies can save federal dollars and improve project efficiency. One such change, a "Dig Once" policy, reduces disruptions and minimizes costs.

Dig Once policy is rooted in the need to promote more efficient use of taxpayer dollars. By coordinating the installation of multiple utilities, such as broadband cables, electrical lines, and water systems, during a single construction or infrastructure project, the policy eliminates the need for repeated excavations, which are not only costly but also cause significant disruption to communities. The policy encourages collaboration between federal, state, and local governments, as well as private-sector partners, ensuring that infrastructure investments are maximized and that future costs and environmental impacts are minimized.

In support of such a policy, we ask that the Committee include the following report language in the Fiscal Year 2027 Transportation, Housing and Urban Development Appropriations bill:

*The Committee directs the Department of Transportation, Department of Housing and Urban Development, and other relevant agencies to implement a Dig Once policy across all future grant opportunities and infrastructure projects involving excavation or roadwork. This policy mandates that, when feasible, agencies coordinate the installation of additional utilities—such as broadband, electrical cables, and water lines—during the initial phases of construction. By doing so, the policy will reduce the need for future excavations, minimizing disruptions to communities, reducing long-term costs, and improving infrastructure efficiency.*


